Simple Cremation - \$ 994.00

Simple Cremation is direct cremation without embalming, viewing, or ceremony. Our Simple Cremation package does not include burial services, use of facilities and staff for funeral ceremonies, viewing of the deceased, memorial services, or embalming. Direct cremation is for families who want a simple and flexible farewell without a viewing or service.

Our charges include:

- Basic services of funeral director and staff.
- Transportation within our local service area.
- Use of a climate-controlled holding facility.
- Electronic filing of the death certificate.
- Notification of passing to Social Security.
- The direct cremation process.
- A travel-safe plastic utility urn.
- A cardboard alternative container.
- The return or scattering at sea of the cremated remains.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are composed of corrugated fiberboard.

Also included in this charge are overhead expenses related to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses.</small>
